- Earnest Money Deposit of Rs. 50,000/- (Rupees Fifty Thousand) only in the form of DD / Banker's Cheque drawn in favour of to the Director, Food Civil Supplies & Consumer Affairs Shillong
- 3. Earnest money deposited by unsuccessful Tenderers will be released after selection process is completed. Earnest money deposited by successful Tenderers will be released when work/supply done.
- 4. The following documents should be enclosed with the Tender:
 - (a) Attested copy of Up-to-date
 - (i) Registration Certificate in form 2 Rule 18 TIN
 - (ii) Central Sales Tax Registration in Form B Rule 5 (i)
 - (iii) Clearance Certificate under MVAT Form 39
 - (iv) Other attested copies of related certificates under MVAT required under Rule.
 - (v) An updated Professional Tax.
- 5. Rates of materials supplied should be inclusive of all taxes and F.O.R to the different Districts and Subdivisional Headquarter(s) in Meghalaya.
- 6. Non Tribal Tenderers should submit attested copy of up-to-date Trading License issued by the concerned District Council
- The Tenderers should enclose an Affidavit on non-judicial stamp paper of Rs. 10/- (Rupees ten) stating that they have not been blacklisted by any Central/State Govt. Departments or Central/State PSUs for the last 3 years.
- 8. In case the Tenderers furnish false information their tenders will be rejected and their EMD stands forfeited
- 9. Copy of Income Tax clearance certificate obtained from the Income Tax Department should be furnished along with the Tender
- 10. Tenderers belonging to SC/ST Community should furnish copy of SC/ST certificate issued by the competent authority
- 11. The Tenderers need to submit documentary evidence with regard to their sound financial status.
- 12. The Tender should be superscript with the word "Tender for Supply, installation, commissioning and maintenance of Point of Sales (PoS) devices for automation of fair price shops" on the outer cover of sealed Tender addressed to the Director, Directorate of Food Civil Supplies & Consumer Affairs, Horse Shoe Building (Ground Floor) Lower Lachumiere, Shillong-793001
- 13. The tenderers should furnish experience certificate to the effect that they had executed such contract work with Government Department/Organization during the last two three years

- 14. Warranty should be for 2 (two) years .
- 15. Successful Tenderers will have to provide necessary service against materials supplied under warranty period.
- 16. Power of attorney / authority letter in favour of the official signing the tender.
- 17. The tenderers should have OEM certificates from the manufacturers
- 18. The authorized dealers/companies should have a functional Service Centre in Shillong with service engineers along with the contact details of the service centres. The Service Engineers should provide services to any part of the State within 24 hours of receipt of complaint.
- 19. The maximum response time for repairing the system shall not be more than 24 hours within Shillong and 48 hours for the rest of the state.
- 20. The response time for any complain should be clearly mentioned and any replacement needed for any computer items should be within 15 days.
- 21. The tenderers shall submit the tender in sealed covers marked as cover I & II. The 1st cover should contain the Earnest Money as indicated above. The 2nd cover should contain the tender documents. The opening of the Tender shall be strictly as per the NIT terms & conditions
- 22. Rates should be quoted both in figures and words inclusive of tax etc. Overwriting and erased against rate, words will be rejected
- 23. Department reserves the right to make any changes in the terms and conditions of the tender

24. Payment Terms:

- For claiming the payment, the following documents are to be submitted to the paying authority: (a) Invoice
 - (b) Delivery Challan/ Bills in duplicate duly pre-receipted
 - (c) Supplier certificate for dispatch
 - (d) Consignee receipt

25. Delivery:

- a) Delivery of the goods and documents shall be made by the Supplier in accordance with the terms specified by the Purchaser in its Schedule of Requirements and special conditions of contract and the goods shall remain at the risk of the Supplier until delivery has been completed.
- b) The delivery of the equipment shall be to the ultimate consignee as given in the purchase order.
- c) The delivery of goods shall commence within 45 days of the placement of order

<u>SHORT TENDER NOTICE FOR IMPLEMENTING PILOT PROJECT FOR FPS</u> <u>AUTOMATION USING POS DEVICES</u>

Introduction:

With the implementation of the National Food Security Act 2013 in Meghalaya, it is objective of the State to ensure the delivery of entitled foodgrains to the identified beneficiaries in an efficient and transparent way. To make such a system efficient and transparent, it has been decided to introduce an online/offline Fair Price Shop delivery system having both Aadhaar and Non-Aadhaar authentication in real-time along with Local One Time Password (OTP) as a factor of authentication. The system will identify and verify the beneficiaries at each FPS when they come to collect their foodgrains.

It is decided that the Pilot FPS Automation project will be for 10 FPSs covering urban, semiurban and rural area in and around Shillong effective from 10th January 2017 to 31st March 2017. After the successful implementation of the Pilot project, a State-wide rollout would be followed tentatively from 1st April 2017.

Scope of work:

The selected vendor shall supply all the required hardware including commissioning and necessary backup support, integrate the hardware with software application, provide two GSM SIM cards from different telecom companies, uninterrupted connectivity, handholding support to train the FPS dealers/Dept. Officials, resource persons for monitoring the project implementation.

The Dept. reserves the right to extend the Pilot Project with the same terms and conditions.

Deliverables by the vendor:

1. POS devices:

The POS devices should be STQC certified with fingerprint scanner and iris scanner (certificate to be attached with TENDER), having minimum specifications attached at Annexure-I. However, POS devices with higher specifications are highly desired.

2. Offline and Online Support:

The vendor should provide both offline and online functionality for each supplied POS devices. Each FPS should be able to conduct an offline transaction at least once and an online transaction at all times. The Dept. also envisages the implementation of Local One Time Password (OTP) as a factor of authentication. It is expected that OTP will be delivered within a reasonable time. OTP validity duration is specified within the message, currently it is kept at 30 minutes.

3. Training Support:

The vendor shall provide hands-on training for the 10 FPS dealers, Dept. Officials, for at least three times, i.e., beginning, midway implementation and ending of the project. The training will have both theoretical and practical components and the training material (booklet, video, CD, etc) will also have to be borne by the vendor. The most important aspect of the training is that it should be in real-time and the FPS transaction will also be captured online.

4. Integration with software application:

The CAS which is developed by NIC, New Delhi, will be implemented for the project. The vendor will be responsible for integrating the CAS with hardware, make trial runs, maintain liaison with NIC experts on a regular basis. The vendor will also be responsible for incorporating changes, improvements, patches, upgrades, revised versions of the CAS rolled-out by NIC.

5. Backup support:

The vendor will have to keep adequate number of additional POS devices ready at his local office in Shillong and will be liable to replace the faulty/unserviceable device within a notice of 1 (one) hour. In case of any fault occurring in any of the installed POS devices/ hardware/software, a service call by phone/fax/email generated by the FPS dealer/ Dept Officials will be honoured and responded accordingly.

6. Technical resources:

The vendor will engage at least 3 (three) Technical Engineers, preferably locals, in Shillong and they should have requisite expertise on the device operations, software applications, hardware troubleshooting skills, etc. and monitor the FPS online transaction on a day-to-day basis. They shall also keep a close liaison with the FPS dealers, Dept. Officials, NIC, UIDAI, Census authorities and submit required reports and feedbacks to the Dept. on a weekly basis.

7. Connectivity:

The POS devices should be provided with 2 (two) SIM cards from different telecom operators. The monthly rental for such connections will be borne by the vendor directly to the respective telecom operators.

8. Authentication:

The Department has envisaged implementing UID and Non-UID authentication as well as the local OTP authentication. The devices must be capable of collecting both sets and perform necessary processing.

If possible, the vendor may identify at least five (5) FPS dealers having beneficiaries who have Aadhaar card for UID authentication. Charges required for UID authentication during online transaction at FPS, if any shall be borne by the vendor. For non-UID authentication, the vendor should come up with a solution of providing an OTP authentication which would be unique, foolproof and easy to use. It is expected that OTP will be delivered within a reasonable time. OTP validity duration is specified within the message, currently it is kept at 30 minutes.

9. Working hours of FPS:

The vendor will have to work with the FPS dealers when it comes to FPS hours of operation. The devices installed by the vendor shall be operated during the working hours of the FPSs.

10. Disqualification:

Selected vendor shall not be entitled to opt out/suspend/withdraw the project as per the contract. It is expected that the vendor shall implement, monitor, and guide the Dept. for implementing the pilot successfully. Any negligence/default from the vendor will be viewed seriously and in such cases, the vendor will be debarred in participating any TENDER/RFP/Tender invited by the department. Such negligence/default will also be reported to the Department of Food and Public Distribution, Govt. of India, and NIC, New Delhi, for information and necessary action.

Submission of TENDERs:

Financial Proposal Details:

Vendor will submit the financial proposal in an official letterhead and clearly state the charges per FPS both in figures and words. The charges should be inclusive of all charges and taxes. The proposal should be signed by the competent authority.

Technical Proposal Details:

The TENDER is invited from organizations that have requisite expertise in implementing similar type of projects in other States/UTs. Therefore, it is required that the vendor submit the detailed technical proposal on operational modalities, technical solution, software details, hardware details, technical specifications, connectivity, training, manpower deployment, etc., to guide the Dept for adopting a suitable methodology for the Pilot Project and subsequent final roll-out in the State. The technical proposals shall be attached in separate sheet along with the financial proposal.

Financial TENDERs with detailed modalities, technical details, resource deployment, integration with NIC Common Application Software (CAS), etc. are to be submitted by Speed Post or in person in sealed envelope to the following address:
